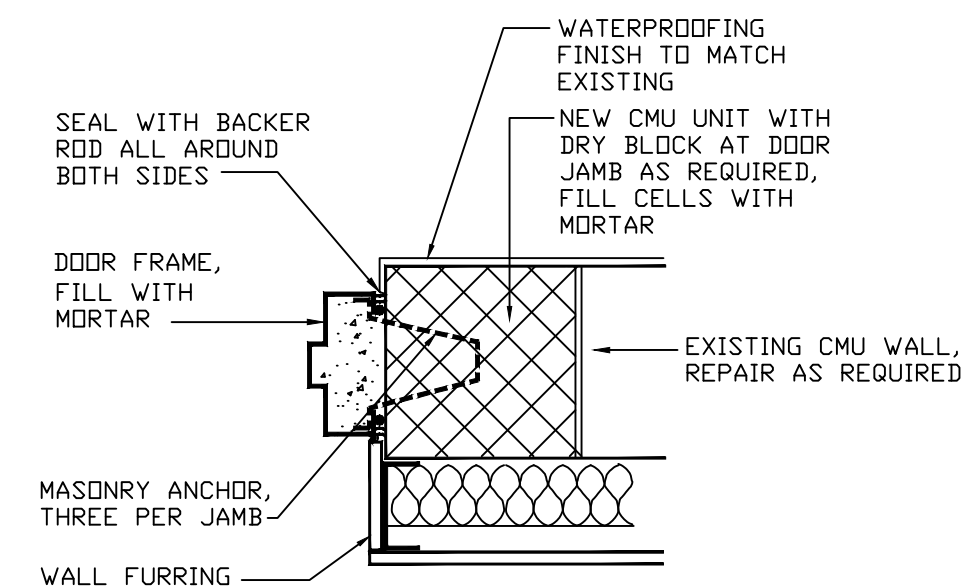

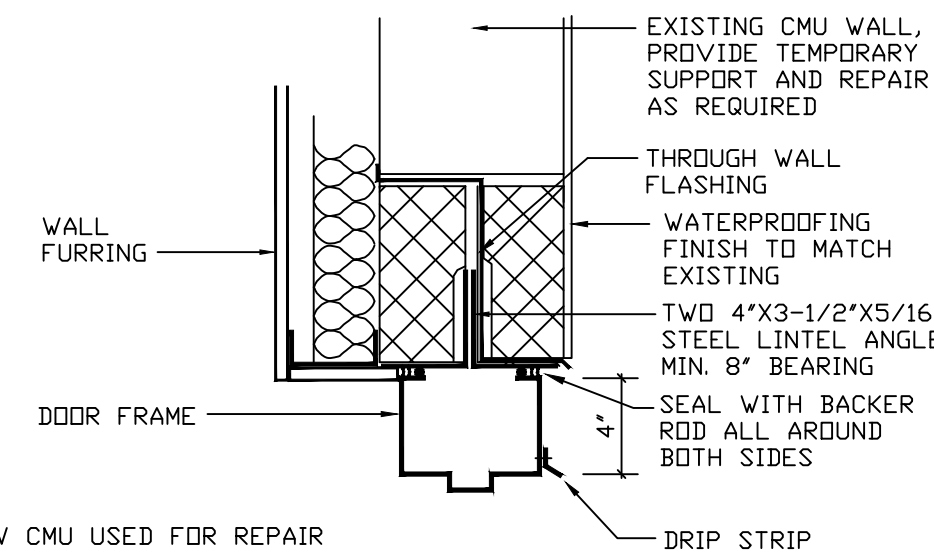

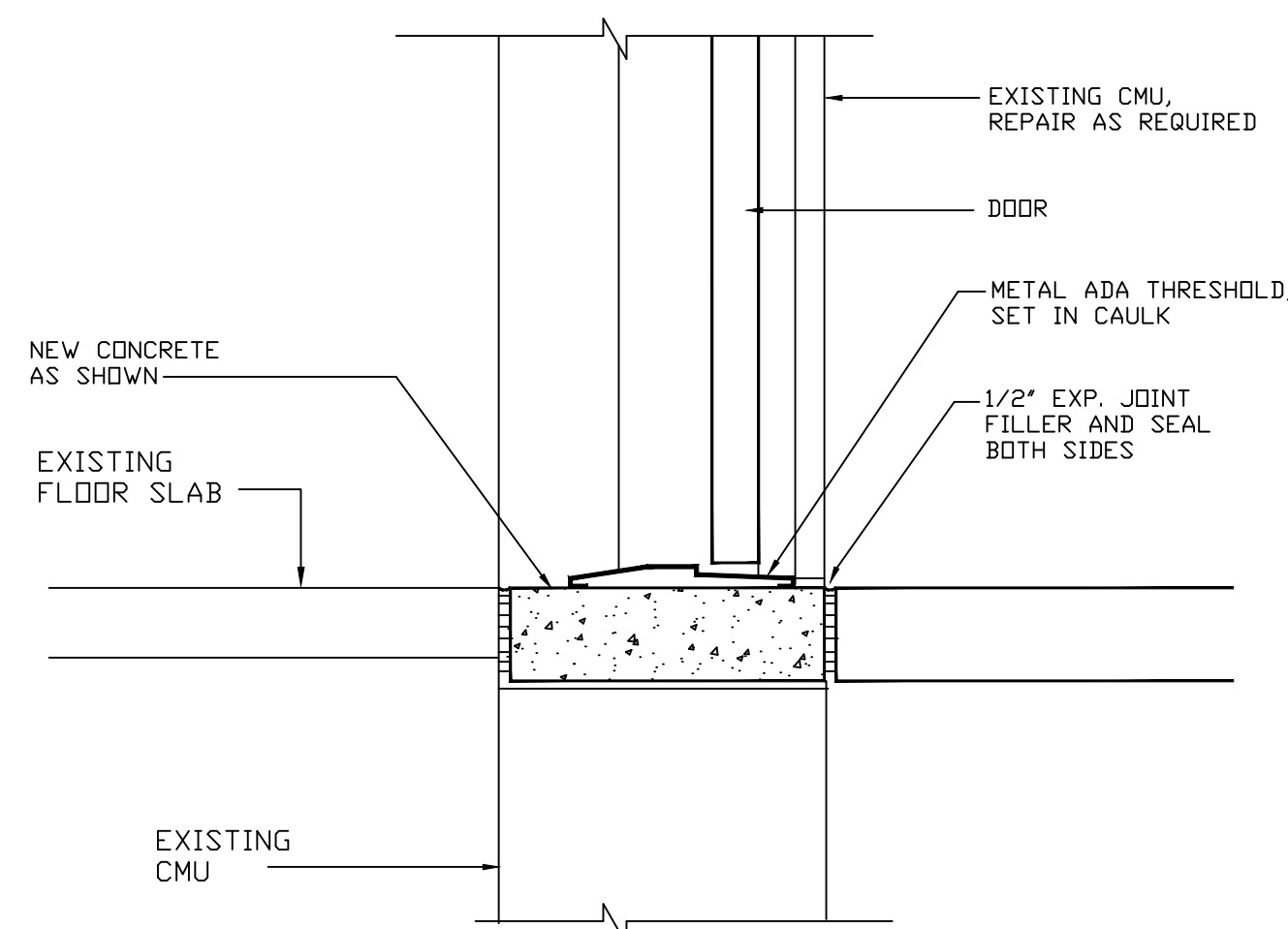


2 DETAIL-DOOR JAMB

METAL DOOR FRAME: METAL DOOR FRAME SHALL BE #F14-4 AS MANUFACTURED BY 'STEELCRAFT'.
 FRAMES SHALL BE ADEQUATELY REINFORCED FOR ALL HARDWARE.
 SUPPLY FRAMES WITH RUBBER BUMPERS, THREE PER STRIKE JAMB.
 FRAMES SHALL BE FACTORY PRIMED SUITABLE FOR EXTERIOR INSTALLATION.

METAL DOORS: HOLLOW METAL DOORS SHALL BE #L-16 WITH POLYURETHANE CORE AS MANUFACTURED BY 'STEELCRAFT'.
 DOORS SHALL BE PROVIDED WITH TOP CAPS FOR PROTECTION AGAINST WEATHER.
